The following types of work may be bid under SR 78 and need no prior approval. However, to ensure that the job you bid falls within the below-listed work, you must complete the attached form and submit it to SMACNA Detroit prior to accepting a purchase order.

1. All three-story hotels
2. All shopping centers (except Somerset and Core Stores)
3. All restaurants
4. Strip stores and retail establishments except union work
5. Churches not to exceed four man crew
6. Wal Mart Stores and similar (not under project agreements)
7. Professional medical and dental buildings **not to exceed four man crew**
8. Municipal, township, public and private schools that are not prevailing rates, harmony agreements or project labor agreements.

**Caution:** Although the above work needs no prior approval. The SR 78 form must be submitted to SMACNA Detroit. This agreement applies only to HVAC work.

The above work will be performed on a three-to-one ratio. (Three Res / Lt Comm Bldg Tradesmen @ \$34.31 and one Bldg Tradesman @ \$58.92. Any company employing more than 8 Res / Lt Comm Bldg Tradesmen must hire at least 1 Bldg Trades Journeyman for this work.

This agreement applies exclusively to field work. This work is on a voluntary basis. Men that are working for this rate will always be hired from the top of the out-of-work list. Furthermore, members choosing to work on these projects will retain their spot on the out-of-work list. Section 26(3).
